The Reporting Person is the operating manager of Revolution Growth UGP II, LLC, the general partner of Revolution II GP, which is the general partner of Revolution II. The Reporting Person has voting power with respect to these shares and as a member of the investment committee of Revolution II GP, may be deemed to share dispositive power with respect to these shares. The Reporting Person disclaims beneficial ownership of the shares held by Revolution II GP except to the extent of his pecuniary interest therein.
